

ইউরোপ, কানাডায় চালু 'মোমেন্টস'

রন্টো, ১২ মে : কানাডা এবং ইউরোপিয়ান ইউনিয়নভুক্ত শুল্কহীন যাত্রা শুরু করল ফেস কগনিশন প্রযুক্তিসম্পন্ন ফেসবুকের ছবি শেয়ারিং অ্যাপ 'মোমেন্টস'। আইনি বিধিনিষেধ কায় এদেশে 'মোমেন্টস' বহারে থাকবে কিছুটা ভিন্নতা।

বিবিসির দেওয়া তথ্য নুযায়ী, ২০১৫ সালে চালু হওয়া ফেসবুকের এই অ্যাপটিকে তথ্য রূপান্তর অজুহাত দেখিয়ে বেশ কিছু দেশে অনুমোদন দেওয়া গনি। অবশেষে নিবেদাজ্ঞার রণগুলো যাচাই করে অ্যাপটির কটি ভিন্ন সংস্করণ তৈরি করল ত্তানটি। ফেসবুকের মতে ভিন্ন সংস্করণ হলেও ব্যবহারকারীরা কটুকটুক করেই অ্যাপের পুরো চার উপভোগ করতে পারবেন।

মোমেন্টস-এর প্রধান ফিচার ন 'ফেস রিকগনিশনের' মাধ্যমে বি যাচাই করে তা শ্রেণিভুক্ত রা। যেমন নও ব্যবহারকারীর হুদের শেয়ার করা ছবিগুলো রংক্রিয়ভাবে 'বন্ধ' দলভুক্ত হয়ে বে। এ ছাড়া শেয়ার করা বগুলোতে থাকা ব্যক্তিদের নাম যংক্রিয়ভাবে ট্যাগ করবে াপটি। ফেসবুক থেকে জানানো রছে বিশেষ সংস্করণে স্বয়ংক্রিয় গের ব্যাপারটি থাকছে না, ট্যাগ রার দরকার হলে তা বহারকারীকেই করতে হবে। দিকে 'ফেস রিকগনিশন'

ব্যবহার করার কারণে কানাডা এবং ইউরোপিয়ান ইউনিয়নের তথ্য নিরাপত্তারক্ষীরা উদ্বেগ প্রকাশ করেছেন। এ খবর প্রকাশের আগের সপ্তাহে ফেসবুকের বিরুদ্ধে 'ফেস

রিকগনিশন'-এর মাধ্যমে বায়োমেট্রিক প্রযুক্তির অপব্যবহারের অভিযোগ করা হলেও তা নাকচ করে দেয় একটি মার্কিন আদালত। আদালতের ভাষ্যমতে, ফেসবুক অবশ্যই ব্যবহারকারীর প্রত্যক্ষ অনুমতি ছাড়া ছবি নেয় না। বিসিসিকে দেওয়া এক সাক্ষাৎকারে 'মোমেন্টস'-এর পণ্য ব্যবস্থাপক উইল রুবেন বলেন, শেয়ার করা
